The rented material must not be altered or damaged. It is not desirable to dispose of liquid materials on the rented plants. In case of improper return of the rented material, we are entitled to charge missing or damaged rented material at the new price. The prices for all rental plants are valid for the entire duration of the event, set-up and pick-up after the end of the trade fair, exclude VAT. A manipulation surcharge of 20% must be charged for new orders during the official set-up and trade fair period. In the event of late registration, no guarantee can be given for proper and timely execution. In case of cancellation of the order up to 14 days before the start of construction, compensation for damages will be charged in the amount of 25 % of the order value, in case of cancellation 7 days before the start of construction 50 % and below 7 days 100 % of the order value. A contract between the exhibitor/customer and the company Gärtnerei Dopetsberger, 4600 Wels, is created on the basis of the order.

Unless otherwise agreed, invoices are due immediately after invoicing without deduction. In the event of late payment, 2% interest on arrears shall be charged for each month or part thereof. The defaulting client undertakes to reimburse any reminder, collection and information costs. Place of jurisdiction and place of performance are Wels/Austria. Austrian law shall apply exclusively. Prices valid until 31.12.2026. Subject to change.
