For legal and organisational reasons, suspension points on the hall ceiling may **only** be provided **by Messe Wels GmbH**. The suspension point is the handover point. For reasons of liability, external installation companies are not allowed to carry out rigging. In the case of non-compliance, the suspensions which were performed in another way will be demounted at the risk and expense of the exhibitor. Further constructions may only be carried out by licensed companies.

Further constructions may only be carried out by incensed companies.

- The suspension point installation is carried out on the last installation day
- The suspensions will be disconnected at the last exhibition day as soon as the trade fair ends.

We kindly ask you to leave the corridors in the vicinity of your stand open.

The general price list applies to modifications and additional orders. Our rental prices are quoted without legal taxes and exclusive of 1% rental contract fee. The rental fee includes the mounting and dismounting (without stand space, distribution boards, connection fees and power consumption). A last minute surcharge of 25 % will be charged for any orders which are placed at the latest 4 weeks before the start of the trade fair. In the case of a delayed trade fair registration, the proper and punctual fulfilment of your order cannot be guaranteed. After the last dismantling day, any materials of the customer which have not been picked up will be disposed at a charge. If the customer, for any reason whatsoever, withdraws from the contract, compensation for damages to the amount of 100% of the order value will be charged in case of order cancellation until 14 days before the start of setup.
