DEPOSIT REGULATIONS FOR THE SET-UP AND DISMANTLING

NO DEPOSIT HAS TO BE PAID during the time of set-up from 16.02. to 20.02.2026!

We kindly ask you to comply with this setup date as far as possible.

Deposit for 4-day area: Hall 22 During the set-up time from Monday, 23.03. to Wednesday, 25.03.2026 and during the dismantling time on Monday, 02.03.2026

Deposit for 5-day area: Halls 20 and 21 During the set-up time from Monday, 23.03. to Tuesday, 24.03.2026 and during the dismantling time on Monday, 02.03.2026

Cars	100,00 € max. parking time 2 hours
Trailers	100,00 € max. parking time 2 hours
Transporters/vans	100,00 € max. parking time 2 hours
Trucks	100,00 € max. parking time 4 hours

The deposit has to be lodged at the respective entry.

In case of entry with a trailer, a deposit to the amount of € 200,- has to be paid for the car and the trailer. This measure is necessary in order to avoid the parking of trailers on exhibition spaces or reserved parking spaces. The exit with a car is just allowed with a trailer.

Provided that the permitted parking time is not exceeded, the deposit will be refunded - during every exit.

REGULATION FOR VEHICULAR ACCESS AND DEPOSITS DURING THE FAIR

During the fair (with exception of the last trade fair date).

Vehicular access is only possible and officially approved until 8.30 am.

During the trade fair, for an absolutely necessary delivery, the entry into the trade fair grounds is only possible in the period from 07.00 to 30 min. before the start of the trade fair or from 30 minutes to 1 1/2 hours after the end of the trade fair. Possible upon payment of a deposit in the amount of € 100.00 (per car/trailer/truck). This will be refunded if the exhibitor leaves the exhibition grounds on time.

Access to the exhibition grounds is only possible upon payment of a deposit in cash. If the time limit is exceeded, the paid deposit amount will not be refunded.

On the last day of the fair (Sunday, 01.03.2026) vehicular access before 05:30 p.m. is officially prohibited.

The official dismantling will start at 05:30 p.m.

1. time frame

Evening events or stand parties at your own stand must be registered by **16. February 2026** at the latest using the enclosed form. and **require the written approval** of Messe Wels.

The events may begin from 5.30 p.m. each day **from 25 to 29 February 2026** and must be completed by 10.30 p.m. at the latest.

Up to 11.00 p.m. there is the possibility to carry out necessary clean-up work on the stand area.

Guests and staff must leave the exhibition grounds by 10.30 p.m. at the latest.

2. musical performances (AKM)

Musical performances at the trade fair stand (from sound recordings or live) are only permitted from 5.30 p.m. onwards.

The maximum noise level of acoustic or audiovisual performances at the exhibition stand must not exceed 60 dB(a), measured at the stand boundary. The consent of AKM must be obtained for this (see Trade Fair Service Booklet - AKM).

3. security and regulatory service

During the event, it must be ensured that **emergency exits are not obstructed and that aisle areas and neighboring stand areas are not included in the activities**. Set-up for the evening event may only take place at the exhibitor's own stand before 5.30 p.m., so that the trade fair can be completed undisturbed for the other exhibitors and for visitors. In order to protect the neighboring stand area from unauthorized entry, damage, etc., **Messe Wels will schedule a sufficient number of security personnel** and order them at the organizer's expense (see flat-rate fee). The organizer of the evening event is liable for any damage or contamination caused by your event. The instructions of the assigned security and order services must be followed.

4. costs incurred

During the evening event, Messe Wels will provide for the opening of the toilet facilities, possible coat racks, possible heating, lighting as well as for the necessary security service in the exhibition halls and, if necessary, in the foyer of the halls. The costs for this will be charged to you with the final invoice and amount to:

- ◆ Evening event from 5.30 p.m. to 10.30 p.m., cleaning flat rate (e.g. aisles, WC facilities) incl. the above-mentioned ancillary costs (heating, security service, etc.) up to 100 persons **€ 811.00** (if this is exceeded, security staff will be charged additionally on an hourly basis) from 100 persons **€ 1.056.00**

5. entrance for the vehicles

Entry into the exhibition grounds for catering vehicles, event technology or music bands is permitted from approx. 5.30 p.m. and is only possible with the appropriate authorization from Messe Wels.

The vehicle and its occupants must be able to prove their identity by means of an entry permit. Please note that all vehicles must leave the exhibition grounds by 24.00 hrs at the latest. Vehicles that remain on the exhibition grounds after 24.00 hrs will be removed for security reasons and a fee will be charged. We ask for your understanding that only delivery and transport vehicles may enter the exhibition grounds. In particular, cars and passenger transport vehicles please drive directly to the designated parking areas.

6. access for service personnel

If you expect external service personnel for your evening event, please send us a list of names by February 16, 2026 at the latest. On the day of the event, the personnel you have registered will receive the required admission authorization at the assigned entrance.

7. access for your guests

Please send us the invitation so that we can inform the security personnel accordingly.

We expressly point out that operating said devices is subject to the Austrian AKM regulations. Solely the demonstration of the devices for customers is excluded thereof.

We therefore advise every exhibitor who puts such devices into operation during the trade fair event to contact the AKM business offices in Linz to agree on a tariff.

VALUE ADDED TAX REGULATION FROM JANUARY 1ST 2011 (RESERVE CHARGE)

Foreign exhibitors (EU and third countries) will be issued the invoices for their ordered exhibition services and secondary services without the legal value added tax.

The turnover tax liability passes on to the recipient of the service (the exhibitor) (Reverse-Charge-Regulation). This regulation is valid only if evidence of the commercial status is provided (valid VAT identification number, confirmation of the tax office for third countries).

The principle of the place of fulfilment and consequently the domestic taxation still apply to entrance tickets and all types of access authorizations.

Non-commercial foreign exhibitors are also subject to the principle of the place of fulfilment and will be charged as domestic exhibitors.

CASH REGISTERS DUTY

Supplying in Austria

Even if an entrepreneur conducts his business from abroad, certain transactions may be taxable in Austria (notably the supply of goods and services, the intra-EU acquisition of goods, imports). Where the supply of goods occurs in Austria or the supply of services is made in Austria (i.e. the place of supply of goods or services is in Austria) such supply is, in principle, taxable in Austria as well. The standard VAT rate is 20 %, the reduced rate is 10 %. Further information is available on the following pages:

COMPULSORY INSURANCE FOR TEMPORARY EXHIBITION STAFF

Dear Sir or Madam,

We kindly ask you to carry out the contribution statements for temporary exhibition staff together with the current wage and salary statements.

Please note:

As of 1 January 2008 there is a statutory requirement according to the Social Law Amendment Act of 2007 to register every employee employed by you before the start of work at the competent health insurance provider.

You can fulfil the obligation to register in two steps:

- * Submit at the latest immediately before the start of work the “minimum details registration” (account number of the employer, names and insurance numbers or the birth dates of the employed person as well as place and date of the employment to be taken up) and subsequently submit the missing information within seven days from the start of the compulsory insurance (full registration) or
- * Submit a full registration already before the start of work.

This regulation also applies for employees employed on a casual basis. The “minimum details registration” has to be submitted for every individual day of employment. The full registration has to be submitted as before within seven days from the end of the calendar month in which the work was done. This registration is also valid as a de-registration.

You have the possibility to submit the “**minimum details registration**” by phone to the ELDA call centre under the **phone number 05 7807 60** or by **fax** to the number **05 7807 61**.

In case of any questions concerning the compulsory insurance and the liability to pay contributions please contact our staff under the **phone number 05 7807 504310**.

The following has to be observed by foreign employers:

If Austrian employees are employed as temporary exhibition staff by foreign employers, these have to be equally registered and de-registered and the contributions have to be charged with the OÖGKK (Upper Austrian Regional Public Health Insurance).

If employees of employers in EU member states are seconded to Austria, these need to present the certification A1 “Certification Concerning the Applicable Legal Regulations”.

If the secondment procedure cannot be resorted to, you have to submit registrations and de-registrations for the temporary exhibition staff and charge contributions with us.

In accordance with § 30 item 2 of the General Social Insurance Law (ASVG) the local jurisdiction of the Gebietskrankenkassen (Health Insurance Providers) is the place at which the employment is performed. The OÖ Gebietskrankenkasse (Upper Austrian Regional Public Health Insurance) is the competent body in this case.

The OÖGKK reserves the right to carry out an audit of levies in the context of the “audit of wage-dependent levies” (GPLA).

EXHIBITION REGULATIONS OF MESSE WELS GMBH



- 1. Scope:** The General Conditions of Participation shall apply to all rental agreements between the Messe Wels GmbH (MW) and the exhibitor as contractual partner, which are concluded within the framework of participation as an exhibitor at exhibitions in which MW acts as the event organiser.
- 2. Registration:** Registration as an exhibitor at the exhibition shall be done in writing using a registration form provided by MW. With the company's signature on the registration, the exhibitor places a binding and irrevocable tender to participate in the exhibition. Provisos, cancellations, supplements and amendments made in the registration form and in the Conditions of Participation shall be redundant. With registration, the exhibitor shall accept the General Conditions of Participation. There shall be no legal claim to conclusion of a contract and participation at the exhibition on the part of the exhibitor. MW shall reserve the right to reject registrations. Reasons for rejection may be: The exhibitor has not settled obligations from earlier events or legal transactions. In the past the exhibitor has violated the provisions of the Conditions of Participation or other legal provisions. The registered products and services contravene the topic of the exhibition or are not considered suitable for other reasons by MW or they contradict other legal provisions and interests.
- 3. Allocation of stand position:** With the confirmation of contract, the exhibitor shall be allocated a stand position, which is specified on the enclosed plan. (Confirmation of stand position). MW shall be entitled to move or close the entrances and exits to the exhibition site as well as the halls and to carry out other physical alterations. After conclusion of contract, MW can change the overall exhibition space of the exhibitor in relation to its position, type, dimensions and size should this be necessary for security reasons, the public order or because other exhibitors are admitted to the exhibition or because changes to allocated positions are necessary for a more efficient utilisation of the rooms and areas. However, such subsequent changes may not exceed what is reasonable for the exhibitor. MW is entitled to change the stand dimensions by a difference of +/- 15% of the confirmed stand position and to change the stand rental fee to the same extent.
- 4. Co-exhibitors, sub-exhibitors:** The co- or sub-exhibitor shall be someone who is present with their own staff and/or offering at the stand of an exhibitor (main tenant). The participation of sub-exhibitors shall only be admissible if they have been registered and approved by MW. A fee must be paid for sub-exhibitors. This approval shall not give rise to any legal relationship between MW and the sub-exhibitor. The same terms shall apply analogously for sub-exhibitors as for exhibitors. The main exhibitor must ensure that this is the case and shall be liable with regard to this vis-a-vis MW.
- 5. Payment conditions:** The exhibitor shall receive an invoice of all ordered and binding services provided in the course of registration. This invoice shall be immediately payable, and payment is the premise for obtaining the exhibition space and the issue of exhibition passes, parking tickets and the like. Additional services can be ordered by the exhibitor in line with the service documents of MW (e.g. advertising services, IT equipment, stand constructions). These shall be invoiced separately, whereby due prepayment may include but is not limited to consumables such as energy, water etc. In general, MW shall be entitled to refuse the exhibitor the due services until the exhibitor has settled their financial obligations towards MW - also those dating from earlier events. To secure claims arising from the contractual relationship, MW shall reserve the right to assert the statutory tenant lien. MW shall assume no liability for damages to retained objects. Should the exhibitor wish an invoice to be changed because the name, the legal form or the address has changed, a payment of €50.00 shall be due for each invoice amendment. This shall also apply to corrections to the value-added tax of foreign companies. If a third party is specified as the invoice recipient, this does not release the exhibitor from their payment obligation. If an invoice is not paid by the invoice recipient, MW will take legal action against the contractual partner. The conditions of payment and due dates of the original invoice shall continue to apply. MW shall be entitled to invoice the exhibitor electronically.
- 6. Termination of contract:** The exhibitor shall have no right to withdraw
- 7. from the contract apart from the statutory rights of withdrawal.** The exhibitor shall have no right to change the exhibition space which they have already rented and in particular no right to decrease the area. Should the exhibitor cancel their participation in the exhibition, then MW shall be entitled to otherwise dispose of the rental area regardless of whether the exhibitor has a right of withdrawal or not. Should the exhibitor withdraw from the contract, they shall undertake to pay until eight weeks prior to the event a forfeit in the amount of 40% of the invoice which was sent with confirmation of the location of the stand.

- In the event of withdrawal at a later date, 100% is payable. Should Wregistration not have been withdrawn pursuant to point 1 by 8 weeks prior to the event and no invoice of all the ordered and binding services pursuant to point 5 was issued, then the forfeit shall be calculated in accordance with the ordered and binding services pursuant to the registration form. If the exhibitor has not occupied the exhibition stand by 12 pm of the final set-up day and MW has not been informed by the exhibitor of the start of setting up, then MW can terminate the contractual relationship with immediate effect. MW shall be entitled to terminate the contract if restructuring and bankruptcy proceedings were initiated and participation at the exhibition was not confirmed in writing by the authorised party within 4 weeks, at the latest 8 weeks, before the start of the exhibition. Should the exhibitor not pay outstanding debts pursuant to the point Payment conditions, the exhibitor shall have violated a duty to respect the rights, legally protected rights and interests in particular of MW. MW shall be entitled in these cases to claim, as compensation, 100% of the invoice amount of the confirmation of location of the stand.
- 8. Warranty, complaint:** Potential defects of the rental shall be immediately reported in writing to MW at the latest before the start of the exhibition, so that MW can remedy these defects. Complaints at a later date cannot be taken into consideration and shall not lead to claims against MW.
 - 9. Liability and compensation:** MW shall not be liable for any damages and losses to the goods brought to the exhibition by the exhibitor or to the stand furnishings. With regard to this, it is irrelevant whether the damages and losses occurred before, during or after the exhibition. The exhibitor has an increased duty of care for the safety of their goods during the setting up or dismantling of the stand as well as during the exhibition and outside the opening hours of the exhibition. In particular, exhibited objects which are valuable and can be easily moved must be secured during presentation and stored at the exhibitor's own risk. The same shall apply to the exhibitors' vehicles parked on the grounds of MW. The exhibitor shall be liable for all personal, property and other damages which are caused in the course of their participation on the grounds of Messe Wels. MW shall assume no liability for false entries in the exhibition catalogue or other types of printed materials. Should it be necessary for MW to change the date or location of the event for whatever reason - in particular due to the COVID-19 pandemic - the exhibitor shall have no right to claim compensation or withdraw from the contract. If it is not possible to hold the event due to force majeure, then MW can, as compensation for costs incurred, invoice for 25% of the services ordered pursuant to point 5. This does not apply in case of cancellation due to COVID-19.
 - 10. Insurance:** MW expressly points out that goods and materials brought by the exhibitor are not insured by MW and that there is no obligation on the part of MW to do so. Each exhibitor shall be obliged to conclude their own exhibition insurance policy to cover such risks. This can be ordered via the service documents of MW.
 - 11. Surveillance:** MW shall provide general surveillance of the hall and the grounds during the exhibition event. There shall be no legal right to surveillance of a specific stand and/or guarding from theft. This must be ordered separately from MW.
 - 12. Stand supervision:** The exhibitor undertakes to open the exhibition stand in accordance with the opening hours and staff it with competent staff. In the event of failure to comply with this requirement and the stand being left unattended, MW shall be entitled to charge a fine of € 700.00.
 - 13. Exhibition passes/parking tickets:** Each exhibitor shall receive a certain number of exhibitors passes and parking tickets corresponding to the size of the stand. Additional numbers can be ordered for a fee.
 - 14. Taking photos, filming:** MW shall be entitled to have photographs taken and films made of the events of the exhibition, the stands and the exhibited goods and to use them for advertising purposes or general press publications.
 - 15. Data protection:** The exhibitor shall grant their explicit consent to publishing the data they disclosed to MW for the purpose of advertising the event.
 - 16. Advertising measures during the exhibition:** As a matter of principle, advertising measures shall only be permitted at the exhibitor's own exhibition stand. Advertising for unregistered companies and products shall be prohibited. As is advertising for any kind of other events with a comparable exhibition theme as well as the laying out and distribution of trade journals which contain advertising for comparable events. MW offers additional advertising forms outside the exhibition stand (external advertising and the like). These can be ordered for a fee. Surveys outside the exhibition stand shall not be permitted.



EXHIBITION REGULATIONS OF MESSE WELS GMBH



17. **Exhibition sale:** The direct sale of products and services registered on the registration form to exhibition visitors shall be permitted. Other products or services, in particular gastronomic services, require a separate permit. All products and services must be labelled in accordance with the Austrian Price Labelling Act (PrAG). MW shall have the right to prohibit the sale of non-registered products. The provision of free catering at the exhibition stand to exhibition visitors for the purpose of customer care shall be permitted.

18. **Stand receptions/noise/product presentations/stand supervision:** Functions at the exhibitor's own stand after the close of the exhibition must be registered with MW three weeks before the start of the exhibition at the latest; they require a permit and are subject to a fee. Functions may be held from 6pm until 10.30pm. Musical performances shall be permitted from 6pm; the volume may not exceed a level of 70 dB at the boundary of the exhibition stand. The provisions of the written approval of MW shall apply. The exhibitor shall exercise consideration for other exhibitors when giving general product presentations at the exhibition stand; the volume may not exceed 70 dB at the boundary of the exhibition stand. Any demonstrations or operation of machines, stoves, etc. shall be conducted in compliance with the applicable safety requirements. The exhibitor undertakes to participate in the exhibition and to staff the exhibition stand with competent staff throughout the hours of opening.

19. **Stand construction, stand design, suspensions:** The rented stand areas shall be handed over without partitions and other fixtures. Stand plans with a construction height of over 3 metres or built over two storeys must be submitted to and approved by MW 2 months prior to the start of the event. With regard to two-storey constructions, 50% of the stand rent will be calculated for the area of the storey. The official requirements with regard to escape routes and sprinkler systems must be adhered to. The costs of this shall be borne by the exhibitor. The sides of the stand facing the neighbour must be kept neutral, white, clean and free of installations above a height of 2.5 metres. It is obligatory to erect a boundary wall to the neighbouring stand which shall be at least 2.5 metres high. These walls can be ordered through MW/WeDesign. An appropriate distance must be maintained with regard to advertising media placed in the direction of the direct neighbours. The erection of closed walls shall be permitted if these do not take up more than 70% of the respective side of the stand, otherwise approval by MW must be obtained. This provision shall not apply if the walls are at least 2 metres from the exhibitor's own stand boundary or are not higher than 1.2 metres. Building over or decorating the exhibition aisles shall not be permitted and shall require approval by MW in special cases. As a matter of principle, decorating the aisles shall not be permitted - the laying of different-coloured carpets or similar measures may in exceptional cases be permitted by MW. The mechanical attachment of objects to floors, walls and hall decorations shall not be permitted. Decorations and the like which contravene the style and content of the exhibition must be changed or removed by order of MW. Suspensions can only be made at the designated suspension points in halls 19, 20, 21.

20. **Suspensions:** For safety and liability reasons, ceiling suspensions can only be manufactured by MW and must be ordered separately. In the event of non-compliance, other suspensions, which have been mounted, will be disassembled at the expense of the exhibitor or respectively an expert opinion from a static engineer must be submitted by the exhibitor. In the event of non-compliance with stand construction and stand design guidelines, the exhibitor must create at their own expense a state in compliance with the contract. MW shall be entitled to instigate these changes at the expense of the exhibitor.

21. **Outside area, tents:** Approval from the technical direction of MW shall be required for the mooring of tents, guys, flagpoles or the like in the outside area. The available supply lines in the ground pursuant to the plans must be taken into consideration. Tents must be erected and operated in accordance with the Austrian ÖNORM EN 13782 version: 2015-06-01 „Temporary structure - Tents - Safety". The inspection log book (tent book) must be kept at the event location and must be presented upon request to the authority. The correct erection of the tent system must be confirmed by an authorised specialist (civil engineer or certified tent master). The inspection results and/or proof must be kept ready and presented upon request.

MW shall not be obliged to keep the exhibition grounds free of snow. Stand plans in the outside area with a construction height of over 5 metres or built over two storeys must be submitted to and approved by MW 2 months prior to the start of the event. The height of constructions in mobile halls is structurally limited to 2.5 metres. The maximum floor load is 500 kg/m². Higher superstructures shall require approval.

22. **Technical stand equipment:** Power, water, light, compressed air and data connections shall be exclusively created by MW and must be ordered from MW. Operation of the exhibitor's own Wi-Fi network at the exhibition stand shall require the consent of MW. Independent intervention in or handling of the supply networks of MW shall be strictly forbidden. MW shall assume no liability for damages caused by performance fluctuations, interruptions by the provider, force majeure or official measures.

23. **Setting-up and dismantling times:** The times for setting up and dismantling shall be announced by MW for each event. Should the times be exceeded, MW shall be entitled to invoice for the costs incurred. Should the dismantling times be exceeded, MW shall be entitled to return the stand location to its original condition at the expense of the exhibitor. A premature, even partial dismantling of the exhibition stand during opening hours shall be expressly forbidden. Under no circumstances shall it be allowed to commence dismantling of the exhibition stand prior to the official end of the event. In the event of violation, MW shall be entitled to charge a forfeit of € 700.00.

24. **Cleaning:** MW shall provide the cleaning of the exhibition grounds and hall aisles. Residual waste shall be exclusively disposed of using the containers and garbage bags provided by MW. MW shall reserve the right to charge a fee for waste disposal. The exhibitor is responsible for cleaning the rented stand area, which shall only be permitted outside opening hours. In the event of non-compliance with these provisions, MW shall be entitled to invoice for the costs incurred. Stand components, carpets, products or the like which are left at the end of the exhibition shall be disposed of by MW for a fee.

25. **Driving on the exhibition grounds, parking:** It shall be permitted to drive with all types of vehicles and at one's own risk only in the marked areas and car parks on the exhibition grounds. Entry to the exhibition grounds for exhibitors and their employees shall only be permitted with a valid pass. It shall not be permitted to drive on the exhibition grounds during the event. MW may make exceptions to this and grant a corresponding entry authorisation. MW shall be entitled to charge an entry deposit for temporary entry authorisations, also during setting-up and dismantling times, in order to limit the maximum stay and thus enable smooth setting up and dismantling operations. If the deadline is exceeded, the deposit shall be forfeited. Camper vans and caravans may only park on the exhibition grounds with the approval of MW. No vehicles over 3.5t and containers, boxes or any kind of empties may be placed on the grounds during the exhibition's opening hours. MW shall be entitled to remove these at the expense of the owner.

26. **Exhibition haulier:** The haulier commissioned by the Messe Wels shall exercise sole haulage rights on the exhibition grounds. Haulage services within the exhibition grounds may only be ordered from them.

27. **Place of jurisdiction, severability clause, fees:** The place of jurisdiction and performance shall be Wels. The exhibitor shall bear the fees and taxes associated with the rental agreement. Should individual terms of these terms and conditions become partially or fully ineffective or should there be a gap in them, then this shall not affect the validity of the other terms. Any such term should be replaced by a suitable provision that comes closest to what the contractual partners would have wanted. Both contractual partners shall waive the right to rescind for lesion beyond moiety pursuant to ABGB [Austrian Civil Code] section 934.

LOCKOUT HOUR

Please note that on trade fair days the halls must be vacated by 7:00 p.m. at the latest in order to ensure optimum security.

CO-EXHIBITORS AND SUB-EXHIBITORS

Messe Wels GmbH refers to point 4. of the Exhibition Regulations, which clearly states that subletting of the stand space, whether for a fee or free of charge, is not permitted.

In the interest of those exhibitors who have decided to participate in the fair, we would like to point out that only products may be exhibited which are listed in the sales program according to the fair registration (see fair regulations points 2., 15. and 16.) of the exhibitor. We ask for your understanding.

DISCLAIMER

Exhibitors are liable for damages that are within their scope. Therefore, please be sure to check whether you are covered by public liability insurance for this eventuality. We also recommend that you take out trade fair insurance against theft, damage, etc. The exhibition grounds are guarded, but theft does occur from time to time. The organizer accepts no liability whatsoever in the event of loss of or damage to exhibition goods or stand equipment brought in or left behind by the exhibitor.

SELF-PROPELLED WORK EQUIPMENT

For legal and liability reasons, the use or operation of self-propelled equipment (e.g. forklifts, lifting platforms, etc.) is prohibited on the entire grounds of Messe Wels. The only exceptions to this rule are equipment belonging to Messe Wels and its authorized forwarding partners. This is exclusively the company Schenker & Co AG.

VEHICLE INSERTION

Entry is only possible via the North Entrance (Maria-Theresia-Straße).

Entry to the halls will take place during the official set-up time and will be coordinated via a security service.

PARKING AREA FOR TRUCK/TRAILER

Parking space for trucks / trailers in the exhibition area are set up and are to be ordered by means of the order form **in the service booklet**. (See plan in the service booklet)

TECHNICAL GUIDELINES STAND CONSTRUCTION

The construction height is set at a maximum of 5 m (row, corner, head and island stands). If the construction height exceeds the normal dimension of 5 m, as well as for all two-storey stand constructions, a plan submission (floor plan, front and side view) to the trade fair management is absolutely necessary. Company logos, company names may only exceed this construction height with the approval of Messe Wels GmbH and the agreement of the neighboring stand owners.

Attention! For two-storey stand structures a sprinkler system is mandatory.

DEPARTURES

For legal and organizational reasons, suspensions (please see form in this exhibition service booklet) from the hall ceiling may only be made **after consultation with Messe Wels GmbH**. Timely submission is absolutely necessary.

FIRE REGULATIONS

Fire alarms, fire extinguishers or hydrants may not be installed - provided they are in the area of your stand location. This will be checked during commissioning before the start of the trade fair. The fire regulations must also be complied with during stand construction.



COMMENCEMENT OF INSURANCE COVER

The insurance contract shall be deemed concluded only upon receipt by the insurer of the offer that has been signed by the policyholder; there will be no insurance cover before that. Your insurance relationship

Personal data

In order to establish our insurance relationship with you, it is essential that we process your personal data. We need this data in order to check whether and on what terms your insurance relationship is established, and in order to be able to determine your insurance claim in the event of a claim. In addition, we use your personal data for your other support, such as to inform you about changes in the legal framework, insofar as these are relevant to your insurance relationship. Personal data" means any information relating either directly or indirectly to natural persons (such as names, addresses, contract data). Even though company and business secrets are not directly covered by the term personal data, we give such information the same protection, and we expect the same from our business partners and customers.

Scope of data use

When you apply to us to take out an insurance policy, you provide us with personal data and, where applicable, also with company and business secrets, both about you and about your relatives, employees or other third parties. In all these cases, we generally assume that you are authorized to disclose this data. We use your data and the data of such third parties named by you in our legitimate interest as the party responsible for your data processing and to the extent that this is necessary for the proper establishment and processing of our insurance relationship with you. On the basis of any separate declarations of consent issued by you, we will also use your data to provide you with further product offers from us, from other companies in our insurance group or from our business partners. For some of our insurance products, it is necessary to process specially protected categories of your personal data. This primarily includes data relating to your health, which we require, for example, for the justification and claims processing in health, life or accident insurance. We only ever process these special categories of personal data in accordance with the provisions of the Insurance Contract Act and on the basis of your consent given in the insurance application. We will not disclose any personal data to you or to your relatives, employees or other third parties. In all these cases, we assume that you are authorized to disclose this data. Passing on data to third parties

Due to the complexity of today's data processing procedures, we sometimes use service providers and commission them to process your data. Some of these service providers are located outside the territory of the European Union. In all cases where we use service providers, however, we always ensure that the European level of data protection and the European data security standards are maintained. It may also be necessary in the course of our business case processing that we transfer or jointly process your data within our insurance company or within our insurance group. In these cases, too, the European data security standards are always maintained. Use of cloud services

As an innovative and future-oriented company, we also use cloud solutions. The cloud services we use are performed by the following providers:

- Microsoft Corp.

- Google Inc.

We use the cloud services primarily as part of our internal and external electronic communications as well as for video conferencing, for our appointment management and for shared document use in our internal collaboration. The storage of your insurance data, in particular your health data, does not take place in these cloud services, but in our data centers.

Involvement of reinsurers

When insuring certain risks, we work closely with our reinsurers, who support us in our risk and benefit assessment. For this purpose, it is necessary for us to exchange data about you and your insurance relationship with our reinsurers. This exchange of data always takes place solely for the purpose of jointly reviewing your insurance risk and your claims, in compliance with the framework provided for this purpose by the German Insurance Contract Act (Versicherungsvertragsgesetz).

Involvement of insurance brokers

If you entrust an insurance broker with your affairs, he or she will collect and process your personal data and forward it to us for the purpose of reviewing your insurance risk, concluding your insurance relationship with us and reviewing our benefits. We also forward personal data about you and your insurance relationship to your insurance broker to the extent that your insurance broker requires this for your support. Because your insurance broker must ensure that your data is used in a manner that complies with data protection regulations, we always take the utmost care when selecting our insurance brokers to work with.

Disclosure of data to supervisory authorities and courts as well as to other third parties

As an insurance company, we are subject to high regulatory requirements and constant supervision by the authorities. As a result, we may be required to disclose personal data about our policyholders to authorities or courts in response to their requests. Likewise, we may need to involve third parties such as doctors, hospitals, appraisers or companies commissioned to settle your claim and provide them with your personal data. In all these cases, however, we always ensure that the legal basis is complied with and that the protection of your data is maintained.

Automated data processing procedures

In order to offer you the most efficient business case processing possible, we use partially automated check programs that determine the insurance risk on the basis of the information you provide in your insurance application and, for example, determine the amount of your insurance premiums or any risk exclusions you may have. We also use such programs to automatically determine our obligation to pay benefits in the event of a claim in certain areas. The test parameters used in these programs are based on actuarial experience and thus ensure an objective standard of assessment. You can refuse to allow such automated procedures to be carried out on you and your business cases and instead request that your matter be processed manually by our company employees in all cases. In this case, we request that you arrange for your supervisor to forward your request to the appropriate department for individual assessment or to notify us of this at kundenservice@wienerstaedtsche.at. Please note, however, that this may sometimes result in a delay in the processing of your business case.

Our data security

As a licensed insurance company, it goes without saying that all data traffic within our company is encrypted. We also have encryption options for external data traffic, provided that you, as the recipient of our communication, have the technical capability to decrypt it. Please note that electronic communication using standard mail programs (such as MS Exchange) does not offer absolute protection against third-party access and that non-European servers may be switched on for this form of communication transmission. It is also a matter of course for us to ensure that our in-house data centers comply with all ISO 27001 security standards. We also transfer our understanding of security to the service providers we use, who we have obliged to comply with similar or equivalent security precautions. If data is stored on servers outside Europe as part of the cloud services we use, we ensure that this data is stored exclusively in fragmented and encrypted form, using the highest encryption technologies. The storage of data relating to your insurance relationship and the storage of your health data always remain in our internal data centers. Your rights

You can request information about the origin, categories, storage period, recipients, the purpose of the data processed by us about you and your business case and the nature of this processing.

If we process data about you that is incorrect or incomplete, you may request that it be corrected or completed. You may also request the erasure of data that has been processed unlawfully. Please note, however, that this only applies to incorrect, incomplete or unlawfully processed data. If it is unclear whether the data processed about you is inaccurate, incomplete or unlawfully processed, you may request the restriction of the processing of your data until this issue is finally clarified. We ask you to note that these rights are complementary, so that you can only request either the correction or completion of your data or their deletion.

Even if the data relating to you is correct and complete and is processed by us lawfully, you may object to the processing of this data in specific individual cases justified by you. Likewise, you can object if you receive direct advertising from us and no longer wish to receive this in the future.

You may receive the personal data processed by us, if we have received it from you ourselves, in a machine-readable format determined by us or instruct us to transfer this data directly to a third party chosen by you, provided that this recipient enables us to do so from a technical point of view and that the data transfer is not prevented by unjustifiable expense or by legal or other obligations of secrecy or confidentiality considerations on our part or on the part of third parties.

Our data retention

In principle, we retain your data for the duration of our insurance relationship with you. In addition, we are subject to a variety of retention obligations, according to which we must retain data about you, about third parties (such as co-insured persons), about your claims and about your insurance relationship beyond the end of the insurance relationship or even after the conclusion of a claim, as is the case, for example, due to retention periods under company law. We will also retain your data for as long as it is possible to assert legal claims arising from our insurance relationship with you. The necessity of processing your data

The provision of your personal data, as well as any third parties you name, is necessary for the assessment of your insurance risk, the establishment of our insurance relationship and the fulfillment of your benefit claims. If you do not provide us with this data or do not provide it to the extent required, we may not be able to establish the insurance relationship you have requested or fulfill your benefit claim. Please note that this would not be considered a contractual default on our part.

If we have received and process your data on the basis of a consent granted by you, you may revoke this consent at any time with the consequence that we will no longer process your data for the purposes stated in the consent as of receipt of the revocation of consent.






TERMS AND CONDITIONS FOR BOOTH CONSTRUCTION | valid as of 01/07/2013

1. General:

1.1 All legal transactions and offers for booth construction and all legal transactions and offers performed under the WEDESIGN brand are based solely on our Terms and Conditions for Booth Construction given below. This also applies to future transactions. Conditions of the customer that differ from our terms and conditions do not apply; this applies even if we do not expressly object to them. The terms and conditions apply to both premade booths (system booths) and booths built to individual order (design booths).

1.2 The booths provided (whether system or design booths) are only leased. All parts delivered are only leased unless the offer and/or order confirmation expressly identifies the elements as sold.

1.3 Offers we submit to the customer are for the purposes of initiating a contract and are non-binding and subject to confirmation unless they have been declared binding in written form. The contract is concluded when we send the customer an order confirmation for his offer.

1.4 All agreements, orders, amendments, and cancellations must be in written form. If the customer has not received an order confirmation 10 days before the event, he must notify us of this immediately in writing. The order confirmation will be accompanied by a list of the services ordered.

1.5 If we are providing assembly, separate agreements apply to the assembly services.

2. Prices

2.1 Prices are exclusive of VAT unless agreed otherwise. All prices are understood to be for lease of the booth for the period of the trade fair unless agreed otherwise.

2.2 Unless agreed otherwise, the price does not include connection fees incurred by the fair, costs of obtaining permits (e.g. structural analysis), or fees of any kind charged by fair companies (including Messe Wels GmbH in its capacity as fair organiser and lessor of space), shippers, processing bodies, customs authorities, etc.

2.3 The customer will pay any new charges for the leased object that arise after conclusion of contract because of increase in VAT, transportation tax, customs, export duties, ocean freight, or similar official directives or regulations.

2.4 We have the right to bill the customer a higher price than the one stated at the conclusion of contract if the higher price is caused by the changes stated in number 2.3.

2.5 Each contract party may request a price adjustment 4 months after the conclusion of contract if the prices for the needed materials or labour and ancillary labour costs have changed by more than a total of 5% because of statutory or collective bargaining changes. The contract party who requests the adjustment must prove that the requirements for it have been met.

2.6 If more than three design changes are requested to a system booth, a flat fee of EUR 25.00 plus VAT will be charged for each further change. After construction begins, changes to the booth layout of system and design booths will only be made if practicable and at additional cost (hourly rate plus materials plus VAT).

3. Delivery time and delay in delivery

3.1 Timely performance of our deliveries and services depends on timely and correct fulfilment of the customer's obligations. This includes timely receipt of all documents to be supplied by the customer, timely clarification and approval of designs (approval of designs is not necessary for fairs organised by Messe Wels GmbH - this will be clarified directly), no obstacles on the customer's side, adherence to agreed payment terms, and other obligations of the customer. If these requirements are not met correctly or in time, the delivery period will be extended accordingly.

3.2 If our delivery is delayed or made impossible by an unavoidable circumstance for which we are not responsible, we are released from the obligation to deliver for the duration of the obstacle and its effects. Claims for damages are excluded. Both parties have the right to withdraw from the contract if such a delay or impossibility of performance lasts for longer than 4 weeks.

3.3 We are not responsible for delays in delivery caused by government restriction of imports like foreign exchange controls, etc.

4. Payment conditions, retention of title

4.1 Payment must be made without discount immediately after receipt of the invoice, unless agreed otherwise in writing.

4.2 The customer only has the right to offset if his counter-claims have been found legally valid in a final decision, are undisputed, or have been recognised

by us. He may also exercise a right of retention if his counter-claim is based on the same contractual relationship. No further right of retention may be exercised.

4.3 Bills of exchange may not be used for payment.

4.4 If the customer's creditworthiness is called into question, we have the right to request immediate payment of all outstanding due accounts and, if no payment is made by a reasonable deadline despite the request, withdraw from the contract and take back the objects we have delivered.

4.5 If payment is in arrears, we have the right to withdraw from the contract without a warning of refusal or to require compensation for damages instead of the payment after setting a reasonable deadline. The right to claim further damages, especially because of delayed payments, remains unaffected.

4.6 The title to purchased objects is only transferred to the customer once the purchase price has been paid in full.

4.7 Our services are always separable.

5. Safety precautions/obligations of the customer

5.1 Cubicles and closable items of furniture are not proof against burglary. The closing mechanisms are only for screening from view. We therefore urgently recommend supervising the booth. We urgently recommend that the customer adequately insure both the entire leased object and the exhibition items and the like (value ca. EUR 500.00 per m² - fair booth construction). We are not liable for objects left behind in the booth.

5.2 If the customer provides materials or documents for the construction of the contractual object, the customer warrants that the construction and delivery of the work performed according to the documents does not infringe on third party intellectual property rights. We are not obligated to verify that the information and documents provided by the customer for construction and delivery do not infringe on third party intellectual property rights. The customer agrees to indemnify us at first request against any claims for damages or other third party claims and to be liable for all damages caused by the infringement of intellectual property rights.

5.3 It is the customer's responsibility to order booth walls. The customer may not use the back walls of neighbouring booths to delimit his own booth area. This does not apply to the technically reasonable use of a booth wall by WEDESIGN if required or approved by Messe Wels. WEDESIGN has the right and obligation to charge for the booth wall without discount even if it is used by a neighbouring booth. Double use is only possible if WEDESIGN constructs both booths.

6. Storage

As a rule, the customer's objects will not be stored for him. If storage is desired in an individual case, a corresponding storage certificate must be issued. We are only liable for the stored objects in case of intent, gross negligence, or breach of essential contractual obligations.

7. Regulations for lease contracts

7.1 The leased object is surrendered only for the agreed purpose and period. Ordinary termination of the lease contract is not permitted. Subletting is only permitted with our express approval.

7.2 The customer must review the condition and completeness of the leased object upon receipt. It must be accepted at the agreed time, but no later than 06:00 PM on the day before the trade fair begins. The customer must accept the object if it meets the requirements. Failure to accept the full performance despite being obligated to do so is equivalent to acceptance.

7.3 Since the leased object is a used item, normal traces of use are not grounds for claims for rectification of defects, compensation, or return. This also applies to variations in colour and surface quality that are typical of the material in question.

7.4 The risk of accidental loss or damage is transferred from us to the leaser when the leased object is handed over. The customer must report loss of or damage to the leased objects to us immediately so that we can coordinate joint steps to reduce/rectify damages. The customer's risk ends when the object is returned to us.

7.5 The customer is liable, regardless of fault, for all losses and damages suffered by the leased object during the time when it is in his keeping. He must pay compensation for all necessary expenditures for manufacture/repair of the leased object, up to a maximum of its value when handed over to the customer. We recommend that the customer insure the leased object against loss, damage, and vandalism at own cost. We will disclose the insurance value of the leased object upon request. Damaged system booth walls will be billed at a unit price of EUR 50.00 plus VAT.

7.6 The lease ends immediately when the event (trade fair) ends and tear-down begins, unless agreed otherwise. Items left behind in the leased booth will be disposed of without compensation for lost value.

7.7 The customer must care for and supervise the entire leased object from handover until the end of the fair. If the customer violates the obligations of care and supervision, he must compensate us for any damages suffered as a result.

7.8 Nailing, painting, or gluing on the leased object is not permitted under any circumstances. If there is any damage, the original price of the leased object will be billed in full. Painting over PVC or wooden walls or sticking on double-sided tape, stickers, or wallpaper that cannot be removed is not permitted and will be considered equivalent to destruction or damage of the leased object. Walls or other construction parts of WEDESIGN that the exhibitor has not ordered but still uses will be billed at their full price.

7.9 The lease fee will not be partially refunded if the customer does not need items included in the standard equipment. Such items cannot be exchanged for or offset against other services.

7.10 WEDESIGN expressly reserves the right to deliver items other than those offered if required on technical or other grounds.

8. Limitation of liability

We are liable for loss of life, bodily injury, and harm to health as per statutory regulations. We are only liable for other damages in cases of intent or gross negligence (subject to clause 3). We are also liable for other damages caused by negligence if they are due to violation of an essential contractual obligation; this, however, is limited to foreseeable damages. This limitation of liability applies to both statutory and contractual claims, especially claims for damages based on warranty. Liability under the Produkthaftungsgesetz (Product Liability Act) is unaffected by these provisions.

9. Copyright and other intellectual property rights

9.1 The draft documents, plans, drawings, construction and assembly documents and the design and concept description remain our intellectual property. The customer may not reproduce, make use of, or disclose to third parties any such documents without our permission. The customer also may not use them to build replicas unless agreed otherwise.

9.2 If the customer violates the obligations contained in number 9.1, he must pay a contract penalty of 50% of the lease fee agreed upon between the parties, or at least EUR 5,000.00 (exclusive of VAT). The contract penalty will be credited against any claims for damages. Further rights, especially to injunctive relief, remain unaffected.

9.3 We retain the copyrights to the documents identified in number 9.1 and the works created by us even after payment of the agreed fee.

9.4 We have the right to place our company or brand name in a reasonable size on the objects constructed by us or according to the customer's designs, especially fair booths. We also have the right to publish or use images of the services performed for advertising purposes free of charge and without requiring special permission from the customer.

10. Data processing

We have the right to process data about the customer concerning or in connection with the business relations in accordance with the Datenschutzgesetz (Data Privacy Act), regardless of whether it originates from the customer or from a third party.

11. Cancellation

If the exhibitor cancels the order 4 weeks before the event, a cancellation fee of 50% of the order value will be charged in accordance with § 909 ABGB. Two weeks before the event, the cancellation fee will be 90% of the order value in accordance with § 909 ABGB and one week before the event the cancellation fee will be 100% of the order value. The cancellation fee is not subject to the court right to reduce or abate fines.

12. Place of performance and jurisdiction

12.1 The place of performance for customer payments is Wels, Austria.

12.2 Austrian law applies. The venue is the court in Wels with subject matter competence.

12.3 If a provision of these terms and conditions should be or become invalid, the validity of all the other provisions of these terms and conditions will not be affected.
